# Registration form questions

### About this guidance

This guidance provides an overview of how to access and progress through the online application to register activities for the R&D Tax Incentive. The guidance is broken down into sections which cover each page of the registration form.

They provide a binding determination as to whether your activities are eligible to be claimed under the program. It is also mandatory that you first obtain an Advance/Overseas Finding for any overseas activities that you will be registering for the R&amp;DTI.</p> <p>For information on advance and overseas findings visit the <a href="http://business.gov.au">business.gov.au</a> website.</p> <p><b>Research Service Providers</b></p> <p>Research Service Providers provide scientific or technical expertise and resources to perform research and development on behalf of other companies. <p>How many employees did the company have *across all companies* at the end of [Income period]?</p> <p><i>Style: Number field</i>  <i>Values: Numerical</i></p>	<p>This is the total number of employees on the company's payroll at the end of the income period covered by this application (including working directors, partners, proprietors, full time, part time, and casual staff).</p> <p>For consolidated groups, this will be the total employee numbers for the entire group.</p>
<p>How many employees *across all companies* were engaged in the R&amp;D activities included in this application?</p> <p><i>Style: Number field</i>  <i>Values: Numerical</i></p>	<p>This is the full time equivalent (FTE) number of staff (including working directors, partners, proprietors, full time, part time, and casual staff) employed by the company on research and development in the income year covered by this application.</p> <p>For employees that do not work full time, calculate their fraction of a full time load and incorporate them into your calculation on a pro-rata basis. For example, a part-time employee that works for half of the hours of a full-time employee would be entered into the calculation as 0.5.</p> <p>For consolidated groups, this will be the total FTE number of staff that worked for all relevant subsidiaries who performed R&amp;D activities included in this application. <p>For your selected income period, what was the company's taxable income or loss *across all companies*?</p> <p><i>Style: Currency field</i> <i>Values: Numerical</i></p>	<p>This is the company's taxable income or loss for the selected income year. Losses should be shown as negative figures.</p> <p>A consolidated or multiple entry consolidated group is a single entity for income tax purposes, therefore the taxable income or loss will be for the group.</p>
<p>For your selected income period, what was the company's aggregated turnover?</p> <p><i>Style: Currency field</i> <i>Values: Numerical</i></p>	<p>Your aggregated turnover is the sum of the annual turnover for all of the following:</p> <ul style="list-style-type: none"> <li>• the company</li> <li>• any entity connected with the company</li> <li>• any entity affiliated with the company</li> </ul> <p>Any dealings between these entities are excluded.</p> <p>An entity's annual turnover is the total ordinary income it derived in the income year in the ordinary course of carrying on its business activities. This amount does not include GST.</p> <p>For non-grouped companies their aggregated turnover will simply be their annual turnover derived in the income year (excluding GST).</p> <p>Further information is available from the <a href="#">Australian Taxation Office website</a>, including the meaning of affiliated entities.</p>

If an activity actually undertaken is materially different from what was described in the finding it may still be eligible. If that activity is conducted in Australia it may still be registered under the R&amp;DTI's self-assessment regime. You must conduct or plan to conduct, at least one eligible core R&D activity to register for the R&DTI.  
 Section 355-25(1) of the Income Tax Assessment Act 1997, the law that applies to the program, states:  
 Core R&D activities are experimental activities:

- (a) whose outcome cannot be known or determined in advance on the basis of current knowledge, information or experience, but can only be determined by applying a systematic progression of work that:
  - (i) is based on the principles of established science; and
  - (ii) proceeds from hypothesis to experiment, observation and evaluation, and leads to logical conclusions; and
  - (iii) that are conducted for the purpose of generating new knowledge (including new knowledge in the form of new or improved materials, products, devices, processes or services)
